2024 Highlights

ADVOCACY

- \$131,846 raised for RPAC.
- 40 major investors.
- Raised over **\$11,500** for RPAC at the 2024 DMAR Excellence Awards.
- Successfully endorsed 9 out of 10 candidates and 2 out of 3 issues in the 2024 election.
- Dancing with the Stars: Realtor® Edition raised nearly \$30,000 for RPAC with a sold-out crowd.

MEDIA EXPOSURE

- 1,200+ media mentions across 118 local and national publications and broadcasts—our biggest media year yet (up 50% from 2023!).
- Generated **\$17.7 million in earned media** from **1.7** billion impressions.
- **15 DMAR members** featured in the media, with a notable uptick in TV and radio segments.
- Featured in outlets like the Associated Press, Better Homes & Gardens, Business Insider, Colorado Public Radio, The New York Times, US News & World Report and The Wall Street Journal.

Advocacy

DMAR's Government Affairs Committee (GAC) has been deeply engaged in advocating for policies and candidates that support the real estate industry and address pressing housing and property rights issues in the Denver Metro area. Below is a summary of our key accomplishments and ongoing initiatives.

ELECTION SUCCESS

To strengthen DMAR's influence and protect member interests, the Association endorsed nine candidates – four incumbents and five for open seats – who won their races in the November 2024 elections. These candidates were rigorously vetted for their voting records, alignment with industry priorities and strong support for Realtor® issues:

Issue Endorsements

DMAR also endorsed key ballot measures aimed at addressing housing and critical infrastructure challenges.

- Denver Health Sales Tax Measure | DMAR supported a 0.34 percent sales tax increase projected to generate \$70 million annually for Denver Health. This funding addresses budget shortfalls caused by uncompensated care, supporting critical services such as emergency, pediatric, primary and mental health care, as well as recovery support.
- South Adams County Water (SACW) & Sanitation District TABOR de-Brucing | DMAR backed the SACW de-Brucing measure, enabling the utility to accept state grants for water infrastructure improvements without TABOR restrictions. This measure prevents costly rate increases for residents by allowing state funding to cover future projects.

ONGOING ADVOCACY EFFORTS

Challenging Lakewood's Anti-Growth Initiative

DMAR is actively supporting a legal challenge to Lakewood's "Save Open Space" measure, which serves as a de facto anti-growth policy. This initiative conflicts with recently enacted state laws and threatens to:

- Reduce housing stock, exacerbating availability challenges.
- Increase affordability issues in an already strained market.
- Hinder Lakewood's ability to meet the housing needs of its growing population.
- Restrict opportunities for first-time buyers and residents seeking to upsize or downsize.

DMAR's contribution to this legal challenge aims to preserve policies that promote responsible development and housing growth.

Improving Denver's Affordable Homeownership Program

DMAR has worked with Denver's Office of Housing Stability (HOST) since 2019 to enhance the Affordable Homeownership Program. Despite delays caused by COVID-19, significant changes were achieved in 2024:

- Elimination of the 35 Percent Front-End Ratio: Previously, a rigid 35 percent debt-to-income ratio prevented many buyers from gualifying. DMAR successfully advocated for updated lending criteria to remove this barrier.
- Expanded Benefits for Buyers and Sellers: The changes have increased the pool of eligible buyers, facilitating more homeownership opportunities while improving marketability for program participants selling their homes.

GAC's proactive approach to candidate endorsements, policy advocacy and community engagement continues to advance DMAR's mission to protect property rights, improve housing accessibility and foster a robust real estate market. These accomplishments reflect our unwavering commitment to our members and the broader community.
